- (iv) That the school shall comply with the provisions of DSEAR, 1973, RTE Act, 2009 and direction/instruction/guidelines issued by the Department from time to time.
- (v) That the school shall comply with the order/guidelines of DoE and judicial pronouncement w.r.t. utilization/maintenance of school funds.
- (vi) That the school shall comply with the orders/guidelines of DoE dated 07/11/2017 and judicial pronouncements w.r.t. safety of the students and shall take all necessary steps to this effect.
- (vii) That the school shall get the approval from the competent authority to run Nursery & K.G. Classes.
- (viii) That the school shall submit the experience certificate in r/o Mrs. Narinder Batra, Manager duly countersigned by the EO/ DEO of the concerned Zone within 02 months or change/ replace the manager.
- (ix) That regular eligible PGT's shall appoint within 02 months as the school has already upgraded up to Sr. Secondary level.
- (x) That the school shall appoint the Medical Staff in the school within 02 months.
